Suspension of Work in the District of Columbia

WMATA SafeTrack Surge #6 – Public Space Suspension August 1, 2016 – August 7, 2016

Due to the upcoming WMATA SafeTrack Plan, Surge #6, in the District, **all construction activities in the Public Right-of-Way will be suspended on roadways in the following locations listed below from August 1, 2016 – August 7, 2016.** This is an effort to eliminate impacts to pedestrian and vehicular traffic in the immediate areas affected by WMATA's expanded bus service for Surge 6 to the affected METRO Stations (Silver Spring, Takoma, & Fort Totten).
